GTU INNOVATION COUNCIL AT A GLANCE:

GTU Innovation Council (GIC) has been designed to establish close bonding between industries, entrepreneurs, faculty members and students to make research and development at the University, relevant to the needs of industries at national and international levels. It helps to create a culture of design, new and products augmentation and processes in the arena of industries. GTU Innovation Council as an innovation campaign has started strategic steps to establish a close and continuing-action for the students in all the undergraduate and postgraduate courses. GTU Innovation Council is one of the elite organizations of the nation for cultivating multilayer innovation ecosystem. Through the efforts for creating culture of innovation and entrepreneurship in 8 years, an aura of developing the ecosystem across the state was conceptualized. The pilot projects and efforts have ideated many policies which have helped to change and shape up innovation and entrepreneurial mind-set of students. GIC is pioneering more than 12 initiatives in 8 sectors of the council.

Also GTU has becomes the India's first university to have Technology Business Incubator (TBI). Department of Science & Technology, Govt. of India approve GTU as a nodal institute to start his own Technology Business Incubator. The TBI dedicated to IoT/ technology based start-ups.

DIFFERENT POLICIES FOR GRANT:

- 1. Student Start-up & Innovation Policy (SSIP) PoC/Prototype grant up to INR 2 Lakh & Patent filling support up to INR 25K approved by NI
- 2. In Start-up Assistance Scheme of Industries Commissionerate, support provided up to 30 lakh per startup as a seed support approved by SLEC
- 3. Rs. 20,000/- per month will be provided to the innovator as sustenance allowance for one year whose project is recommended and approved by SLEC
- 4. In case of start-up having at least one woman co-founder, Rs 25,000/- per month per start-up will be provided as sustenance allowance approved by SLEC
- 5. An additional support up to 10 lakh will be provided to start-up having innovative project which have significant impact on society, based on condition on approval/sanction given by SLEC.
- 6. Assistance up to 3 lakh per approved start-up will be provided to enroll and participate for national/international recognized acceleration programs approved by IC
- 7. Assistance Up to 1 lakh per approved startup for skill development support approved by IC
